**COMPLAINT FOR DIVINE INDICTMENT  
FOR LOSS OF THE FEAR OF GOD**

**COMES NOW**, the Plaintiff, **THE LORD GOD ALMIGHTY**, by and through His Sovereign Authority, and brings this Complaint for Indictment against **The Church**, hereinafter referred to as *Defendant*, and alleges as follows:

**JURISDICTION AND VENUE**

This action is brought before the **Eternal Court of Heaven**, whose jurisdiction is eternal, universal, and absolute.

Venue is proper as this matter concerns violations of divine law, covenant obligations, and spiritual statutes established in the everlasting Word of God.

Authority is drawn from Scripture, including but not limited to: Hosea 4:1; Jeremiah 2:19; Romans 3:18; 1 Peter 4:17.

**PARTIES**

**Plaintiff:**

**THE LORD GOD ALMIGHTY**, Creator of Heaven and Earth, Sovereign Judge, Lawgiver, and King.

**Defendant:**

**THE CHURCH**, being all those who profess the Name of Jesus, yet have departed from the fear, honor, and reverence required by covenant.

1 **STATEMENT OF CLAIM**

2 Plaintiff hereby issues the following legal complaint: **“You are guilty of losing My fear, and I call you**  
3 **to account.”** This indictment constitutes a charge of spiritual negligence, covenant violation, and dishonor,  
4 requiring an answer before the Court of Heaven.

5  
6 **GENERAL ALLEGATIONS**

7 (These paragraphs apply to all Counts)

8 Plaintiff is holy and must be regarded as holy by all who approach Him (Leviticus 10:3).

9 Defendant has treated sacred things as common, forsaking reverence and the fear of the Lord.

10 Defendant has allowed culture to reshape holiness rather than being salt and light. Defendant demonstrates  
11 familiarity, irreverence, and casualness in the presence of the Almighty. Defendant has blended with worldly values  
12 contrary to the mandate of being a peculiar and holy nation.

13  
14 **CAUSES OF ACTION**

15 **COUNT I — LOSS OF DIVINE HONOR**

16 Defendant has dishonored God by replacing holiness with hype, reverence with routine, and purity with  
17 performance.

18  
19 **COUNT II — FAILURE TO RECOGNIZE GOD’S HOLINESS**

20 Defendant enters the house of God with behavior inappropriate even for earthly courtrooms, showing  
21 greater respect for human judges than for the Judge of all flesh.

22  
23 **COUNT III — NEGLECT AND EXCLUSION OF GOD’S PRESENCE**

24 Though God desires to inhabit the praises of His people, Defendant has locked Him out through pride,  
25 entertainment, and spiritual dullness.

26  
27 **COUNT IV — APOSTASY AND COMPROMISE**

28 Defendant has tolerated false doctrine, embraced lukewarmness, and feared man more than God.

1 **COUNT V — FAILURE TO PURSUE HOLINESS**

2 Defendant has disregarded the command to perfect holiness in the fear of God (2 Corinthians 7:1) and ignored that  
3 without holiness no man shall see the Lord (Hebrews 12:14).

4  
5 **COUNT VI — MISPLACEMENT OF THE FEAR OF GOD**

6 Defendant has lost the treasure of the fear of the Lord entrusted to them (Isaiah 33:6), failing to safeguard it as  
7 commanded.

8  
9 **EVIDENCE**

10 Plaintiff submits the following exhibits:

- 11 1) **Exhibit A:** Defendant’s words and actions recorded in heaven (Matthew 12:36).
- 12 2) **Exhibit B:** Casualness in worship.
- 13 3) **Exhibit C:** Compromise, mixture, and spiritual apathy.
- 14 4) **Exhibit D:** Lack of repentance despite conviction.
- 15 5) **Exhibit E:** Tolerance of sin, false prophets, and cultural influence.

16  
17 **FINDINGS OF THE COURT**

18 Upon review, this Court find Defendant **guilty** of:

- 19 • Abandoning fear of the Lord
- 20 • Dishonoring the presence of God
- 21 • Compromise with the world
- 22 • Negligence of holiness
- 23 • Losing spiritual sensitivity and conviction
- 24 • Having a form of godliness but no power
- 25 • Using My Name but won’t follow My ways.
- 26 • Wearing My cross but rejecting the crucifixion of your flesh.
- 27 • Wanting My salvation but not My lordship.
- 28 • Wanting My glory without the humility I require.
- Wanting My oil, but not the crushing that produces it.
- Wanting revival without repentance.
- Wanting to go to church and have church, but not actually be My Church.

However, the Court notes that this indictment is issued **as mercy**, calling the Defendant to repentance and restoration.

1 **REQUIRED RESPONSE**

2 Lord God Almighty, I repent. Forgive me for losing Your fear. I've been casual when I should have been  
3 consecrated. I've flirted with the world when I should've clung to the cross. I've treated Your presence as  
4 common when it is holy. But today, I return. Restore to me the fear of the Lord. Let it burn in my bones  
5 again. Let it humble my heart again. Let it kill my pride and awaken my honor of You. Make me Your holy  
6 people, a peculiar people remarkably different from the culture around me. A people who fear Your name above  
7 all and not ashamed of it. May Your glory rest upon me once more. Today, as an act of my will, I choose the fear  
8 of the Lord according to Psalm 1:29. Help me love what you love and hate what you hate.  
9 In the name of Jesus. By the blood of Jesus. Through the power of the Holy Ghost. Amen and amen.

10  
11 **PRAYER FOR RELIEF**

12 **WHEREFORE**, Plaintiff prays that the Court order the following:

- 13 A. Restoration of the fear of the Lord.  
14 B. Renewal of holiness, honor, and obedience.  
15 C. Revival of spiritual sensitivity.  
16 D. Deep repentance and full return to covenant standards.  
17 E. Manifestation of divine presence as promised in John 14:21.

18  
19 **FINAL ORDER**

20 **The Court hereby rules:**

21 "When you tremble at My Word and sanctify room for Me, you have found My treasure again – the Fear of God."
